## Pro Speck Series Sponsorship Form

The 2010 SFA Pro Speck Series launches in April with four stops along Louisiana.

The first stop will be at the Coco Marina in Cocodrie, LA on April 17 & 18, 2010. First flight of boats will go out at 6:00 am, or safelight, and weigh-in will begin at 1:00 pm.

The second stop is in Lake Charles, LA on May 1 & 2, 2010. Boats will launch from the Calcasieu Point Landing at 6:00 am, or safelight. Weigh-in will begin at 2:00 pm at the Lake Charles Civic Center. This tournament will be held in conjunction with the 53<sup>rd</sup> Annual Contraband Days Festival, an annual tribute festival to legendary pirate Jean Lafitte. This event attracts around 5,000 people per day with its carnival rides, concerts, etc.

The third stop is May 22 & 23, 2010 at the Delta Marina in Empire, LA. Launch time is at 6:00 am, or safelight, and weigh-in will begin at 1:00 pm.

The fourth and final stop will take place at The Dock of Slidell on June 5 & 6, 2010 in Slidell, LA. Launch will be 6:00 am, or safelight, and weigh-in will begin at 1:00 pm.

We have three levels of sponsorship to choose from: Headline, Supporting and Participating. All sponsorship money will go toward the payout.

Headline Sponsors receive bulk space at all of our tournaments, unlimited banner spaces at every tournament site, one team entry in the series with 1-yr membership for team members, advertisement on tournament backdrop, flyers and SFA website. Headline Sponsorship is \$2,500 for the series.

Supporting Sponsors will receive a booth space near the stage during the tournament and a table at the tournament check-in on Friday night to advertise and sell or give away your product. Sponsor will receive three banner spaces at tournament site, advertisement on tournament backdrop, flyers and SFA website. Supporting Sponsors will also receive one team entry with 1-yr memberships for team members. Supporting Sponsorship is \$500 for one stop or \$1,500 for the series.

Participating Sponsorship is for companies that don't need a booth space but want to advertise and enter a team. Participating Sponsors will receive a team entry with 1-yr membership for team members, one banner space at tournament site and advertisement on tournament backdrop and SFA website. Companies are allowed to enter more than one team per stop. Participating Sponsorships start at \$350 for one stop or \$1,250 for the series.

All sponsorships must be mailed in and postmarked no later than entry deadline date for tournament entered. Companies sponsoring the entire series must be postmarked no later than April 5, 2010.
